

WARRENTON HUNT, INC.

Assumption of Risk, Waiver of Liability and Indemnity Agreement Relating to the Warrenton Hunt Clay Shoot and COVID-19

The undersigned desires to participate in the **Warrenton Hunt Clay Shoot** (the “**Clay Shoot Event**”), sponsored by the **WARRENTON HUNT, INC.** (“**WH**”) and organized by **Rick Hemingway** of the **Back Woods Quail Club** (collectively, the “**Organizer**”) on the property of **Arthur and Kimbrough Nash** and **Granville Farm, LLC** (collectively, the “**Landowners**”). In consideration of being permitted to participate in the Clay Shoot Event, the undersigned, as set forth herein has agreed to execute this Assumption of Risk, Waiver of Liability and Indemnity Agreement (this "Agreement") and acknowledges and agrees as follows:

I acknowledge and understand that participating in the Clay Shoot Event involves certain inherent risks, hazards and dangers, including but not limited to, the risk of death or serious personal injury, especially since guns and other firearms are almost always located at premises where the Clay Shoot Event occurs and the use of firearms is involved with the Clay Shoot Event. I represent that (a) I am in good physical conditioning required, and have the degree of skill and knowledge necessary, for me to engage in the Clay Shoot Event, (b) I am familiar with firearms in general and specifically with the firearm I will be using for the Clay Shoot Event, and (c) I thoroughly understand the firearm’s operation and have inspected the firearm and found it to be safe and in good working condition. I voluntarily agree to assume all such risks, as well as any other risks involved in participating in the Clay Shoot Event, as the case may be, including but not limited to the risks of (i) death or personal injury related to the handling of firearms, ammunition, clay targets, shots from firearms and being near others that have firearms in their possession; (ii) ear damage from noise and (iii) outdoor encounters with wildlife, animals, insects and inclement weather.

I further acknowledge that the Coronavirus (COVID-19), has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and can spread from person-to-person and from contact with infected surfaces. By signing this Agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to assume the risk that I may be exposed to or infected by COVID-19 by attending Clay Shoot Event, and that such exposure or infection may result in personal injury, illness, permanent disability, or death. I understand the risk of becoming exposed to infected by COVID-19 at Clay Shoot Event may result from or be caused by the actions, omissions, or negligence of myself and others, including, but not limited to, the Organizer, the Landowners, the WH, and their respective agents, employees, subscribers, landowners, guests, invitees, licensees, other event participants or attendees, or other third parties.

I hereby agree to waive, release and give up any and all rights that I or my heirs, personal representatives, agents, assigns or subrogees may have to make any claim or bring any action against (a) WH, any of its directors, officers, employees, agents, Masters of Foxhounds, staff, subscribers, guests, licensees, invitees and participants, (b) the Organizer, its agents, employees, licensees, invitees and guests, and (c) Landowner(s), its agents, employees, tenants, licensees, invitees and guests, and I further voluntarily agree to assume all of the herein stated risks and accept sole responsibility for, any injury to myself (including, but not limited to, personal injury, disability, illness, and death whether or not related to participating in the Clay Shoot Event and/or related to COVID-19 or other public health risk), damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance or participation in the Clay Shoot Event. On my behalf and on the behalf of my heirs, personal representatives, agents, assigns or subrogees, I hereby agree to indemnify, release, covenant not to sue, discharge, defend and hold harmless (i) WH, any of its directors, officers, employees, agents, Masters of Foxhounds, staff, subscribers, guests, licensees, invitees and participants, (ii) the Organizer, its agents, employees, licensees, invitees and guests, and (iii) Landowner(s), its agents, employees, tenants, licensees, invitees and guests from any claims or causes of action of any kind arising from or related to any injury to myself (including, but not limited to, personal injury, disability, illness, and death whether or not related to participating in the Clay Shoot Event and/or COVID-19 or other public health risk), damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance or participation in the Clay Shoot Event.

I HAVE READ THIS RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
