## Assumption of Risk, Waiver of Liability, and Indemnity Agreement Relating to COVID-19

In consideration of the opportunity to participate in equine activities and social functions such as foxhunts, meets, shows, trail rides, races, social events, dances, balls, meetings, tailgates, hunt breakfasts or other similar activities and events (the "WH Events") sponsored by the WARRENTON HUNT, INC. ("WH"), including activities and functions on the real property of landowners whose land is used by WH ("Landowner(s)"), the undersigned, as set forth herein (Agreement) acknowledges and agrees as follows:

The Coronavirus (COVID-19), has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and can spread from person-to-person and from contact with infected surfaces.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by attending any WH Events, and that such exposure or infection may result in personal injury, illness, permanent disability, or death. I understand the risk of becoming exposed to infected by COVID-19 at WH Events may result from or be caused by the actions, omissions, or negligence of myself and others, including, but not limited to, WH, its masters, staff, agents, employees, subscribers, landowners, other event participants or attendees, or other third parties.

I hereby agree to waive, release and give up any and all rights that I or my heirs, personal representatives, agents, assigns or subrogees may have to make any claim or bring any action against (i) WH, any of its directors, officers, employees, agents, Masters of Foxhounds, staff, subscribers, guests and participants, and (ii) Landowner(s), its agents, employees, tenants and guests, and I further voluntarily agree to assume all of the herein stated risks and accept sole responsibility for, any injury to myself (including, but not limited to, personal injury, disability, illness, and death whether or not related to COVID-19 or other public health risk), damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance or participation in any WH Events. On my behalf and on the behalf of my heirs, personal representatives, agents, assigns or subrogees, I hereby agree to indemnify, release, covenant not to sue, discharge, defend and hold harmless (i) WH, any of its directors, officers, employees, agents, Masters of Foxhounds, staff, subscribers, guests and participants, and (ii) Landowner(s), its agents, employees, tenants and guests from any claims or causes of action of any kind arising from or related to any injury to myself (including, but not limited to, personal injury, disability, illness, and death whether or not related to COVID-19 or other public health risk), damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance or participation in any WH Events.
